#### A huge thank you to Stephen Pilliner before his retirement

September brings the end of the meteorological summer as a milestone in the annual calendar.

This September brings another milestone for us as a Department, with the retirement of Steve Pilliner, Head of Transportation and



Highways. Steve will retire at the end of September after over 44 years in Local Government.

Steve joined Carmarthenshire County Council in 2000 as Transport Manager and progressed to his current role of Head of Transportation & Highways.

Steve and the team have delivered many significant capital highway and transportation related projects over the years that include new highway schemes, bridge structures, active travel infrastructure, community transport initiatives and kickstarted our electric charging infrastructure, providing a sound footing and legacy for more sustainable future to meet our transportation needs. One of the most recent notable successes was the procurement of electric buses and the commissioning and construction of the accompanying new bus terminal and electric charging station at Nant y Ci Carmarthen. This has enabled Transport for Wales on behalf of Welsh Government to run an electric bus service between Carmarthen and Aberystwyth.

Another significant and notable achievement that was outside Steve's normal scope of service delivery was to head up a team during the Covid pandemic that delivered the construction of several field hospitals across Carmarthenshire. This was quite a sizeable and impressive achievement in a short time frame with the various teams pulling out all the stops under Steve's leadership, applying his trademark meticulous attention to detail to ensure that delivery was on time and within budget.

Steve is of course a respected member of the senior team, not just here in Carmarthenshire, but across the professional spectrum and various for arelating to transport and infrastructure across Wales.

Steve has been a stalwart for the Department when uncontrolled events occur – usually weather related emergencies. His style and methodical application in chairing various internal emergency response groups over the years have been exemplar. Maybe Steve will not miss the emergencies, but it is fair to say that we as a collective have learnt a great deal from his experience in this respect.

I would therefore like offer Steve best wishes in his retirement on behalf of the whole Department, his colleagues across the Council and in particular from myself as Director for all the dedication and commitment shown during his career with Carmarthenshire and the legacy that he will leave. #### **Property Portfolio Re-alignment:**

I would like to update you on the outcome of a recent review of property management arrangements across the Council following the previous disaggregation of the housing maintenance function.

This latest review was predominantly focussed on the wider property management and maintenance functions that form part of two Council Departments – Place & Infrastructure and Chief Executive's.

Property maintenance and design functions have been the subject of several reviews over a number of years that have resulted in various outcomes, including the disaggregation of property and housing maintenance functions.

The most recent review focuses on synergies between the strategic management of our properties (within the Chief Executive's department) and how our maintenance

programmes and associated works (within the Place & Infrastructure Department) align with the wider property strategy and corporate priorities.

Currently responsibility for all property related functions sit in three different departments across the Council; Communities (housing), Chief Executive (strategic property asset management) and Place & Infrastructure (maintenance, compliance and design).

The most recent review identifies that our current arrangement of having responsibility for our property portfolio spread across departments as set out does not provide the best approach for a joined-up and coordinated approach to managing our property portfolio.

Having given these aspects much though, it was clear that there needs to be a more cohesive approach to managing our property portfolio.

Therefore, it has been concluded that the property maintenance and design aspects of the service within Place and Infrastructure will transfer to the Chief Executive Department, reporting to Jason Jones, Head of Regeneration, Policy and Digital. It is anticipated that this transfer will take place towards the end of September or early October.

This move will not affect the current arrangements pertaining to the maintenance of the Council's housing stock. This aspect will remain within the Communities department.

I would like to reassure you as teams within the property maintenance and design units that the driver for this review and the outcomes therefrom are to provide a more cohesive and strategic property management service across the Council. Therefore, please be assured that the reasons for the proposals as set out is to provide more surety and integration from a corporate perspective. This is not a cost cutting exercise.

From my perspective as
Director, yes, it is always
a wrench when staff are
transferred out of the
Department, but I am
confident that the proposals
set out are right from a
Council wide perspective
and will provide stability for
the future.

Finally, I would like to sincerely thank you all in the various property related teams for your hard work and dedication in delivering professional design, construction and maintenance functions for the Council as part of this department. I am confident that you will of course continue to do so from within the Chief Executive's department in your usual professional and dedicated manner.

Here's a message from Lucy who has recently joined the Waste Strategy Team:

"Hi I'm Lucy and in 2018 I went to Oxford Brookes University to study Animal Biology and Conservation. Earlier this year I went to the Master of Science Exeter University to study Island Biodiversity and Conservation where I achieved a first class (in between working as a litigation paralegal in Jersey C.I.



I am now a Graduate Trainee in Circular Economy, Waste Strategy & Policy.

I applied as I've always had a desire to have a career dedicated to environmental stewardship.

My first fortnight in post involved site visits to our household waste and recycling centres and depots to understand how our waste services operate and are distributed throughout the county as well as meeting with key members within waste and environmental services to understand the overall structure of the service and the responsibilities of and interaction between factions that comprise the service.

Within my first two months I have created a survey (undertaken by our waste and recycling wardens) to ascertain how, why and when residents use services at the HWRCs. I have analysed this survey data and written a report on it which I will soon supplement with additional data from gravimetric testing.

I have received web training and have updated the council website when waste disruptions transpire.

I have assisted in a review of components of our communal waste provision, managing the action log and will soon be engaging in a scoring exercise to identify which sites are to be retained, altered, or removed. I have consolidated all available, current data on circular economy activities within the Ten Towns (regarding current activities and future goals) from consultancy reports and my own research in addition to engaging with a variety of teams within the council (regeneration, education, food development) as well as external organisations to ascertain the nature, locality and scale of current support and funding provision for the Ten Towns communities.

Supplementary to this work is the report I have started writing on the carbon benefits associated with different categories of circular economy activities. There is currently no framework (statutory or otherwise) pertaining to the carbon benefits of circular economy activities, especially outside the sequestration context.

I am hoping to obtain Carmarthenshire-based carbon statistics which could help form the basis of a local carbon quantification framework across different categories of circular economy activities. Most recently I have been coordinating actions and strategy for a waste transformation project as part of our preparation for the workplace separated waste collection regulations coming into force in April 2024."

# The Tywi Centre 'Up in Lights'

The Tywi Centre, which is part of the Built Heritage Service in our Place & Sustainability Division, recently played a star role in an BBC TV and online article.

The Tywi Centre, which delivers advice and training on the care and repair of traditional buildings across Wales, highlighted the shortage of builders with the skills and understanding on how to look after our old buildings.

When we have half a million buildings in Wales over 100 years old, including traditional terraces and old farmhouses, we need to keep them in good working order. The environmental and economic cost of their replacement is enormous. Nell Hellier, Senior Built Heritage Officer, says 'It is simple: maintain your building – give it an annual MOT as you would your car, clear out gutters, paint windows, remove vegetation, but also use breathable materials like lime renders to keep your building dry and warm.'
